Sub: Receipt of new NFS Card applications and cancellation of ineligible beneficiaries NFS Cards

It has been brought to the notice of this department that families meeting exclusion criteria and otherwise also ineligible have got the NFS Cards. Such families were given opportunity to surrender/deposit their NFS cards within one month of the advertisement published in the newspapers on 14/08/2015. As per Public Notice, if any ineligible family is found misusing NFS card facility after this period, legal action as per norms will be initiated against him/her.

Therefore, all FSOs are directed to identify such ineligible households and cancel their NFS cards and send daily report to the concerned zonal ACs. Zonal ACs will send the weekly report to the CFS through concerned Special/Joint Commissioners. Zonal ACs will monitor the work of cancellation/rejection of NFS cards. 1st appeal against the decision of FSO may be filed with the concerned Zonal Asstt. Commissioner. 2nd appeal may be filed with the concerned ADM as District Grievance Redressal Officer.

System Analyst (IT Branch) is directed to take necessary action to make necessary provision in the portal through NIC for cancellation /rejection of such NFS cards.

Further, receipt of new applications under NFSA should not be refused in the circle offices. On receipt of new application, Zonal Asstt. Commissioners should ensure that the data entry should be done in the respective circle offices for processing the applications. However, new NFS cards will be issued only if Govt. of India increases the present cap of 72.78 lakh beneficiaries or on cancellation of sufficient number of ineligible households cards. To have an assessment of the population who are eligible and beyond the limit of 72.78 lakh, IT Branch will ensure that NIC maintain a waiting list of approved application who are automatically approved to get ration as soon as vacancy is created due to deletion of ineligible persons. Maintaining of waiting list will also help in taking further policy decision in this regard.
