Sub: Declaration of Assets and Liabilities by Public Servants under Section 44 of the Lokpal and Lokayuktas Act, 2013- Clarification regarding formats to be used for Filling returns under the Act.

- 1. In continuation of this office circular no. 7089 dated 26/11/2014 regarding Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the limit for exemption of Assets on Filing Returns) Rules, 2014, I am directed to forward herewith a copy of letter No. 407/12/2014-AVD-IV-B dated 18/03/2015 from the Jt. Secretary (V-2), Govt. of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, New Delhi alongwith it's enclosures on the subject cited above and to say that all the Public Servants i.e. Group A to C including erstwhile Group-D employees prior to 6th Central Pay Commission are required to submit their declaration of Assets and Liabilities in the prescribed amended proforma / form-I, II, III and IV as per details/ schedule as below:-
 - (i) The first return (as on 1st August 2014) under the Lokpal Act should be filed on or before the 30th April, 2015.
 - (ii) The next Annual Return under the Lokpal & Lokaykta Act, 2013 for the year ending 31st March 2015 should be filed on or before 31st July, 2015, and
 - (iii) The Annual Return for subsequent year as on 31st march every year should be filed on or before 31st July of that year.
- 2. The above being Statutory provisions, all the Officers/ Officials working in this Department are directed to file their declarations/ returns in aforementioned Form-I, II, III and IV and forward the same to this Branch strictly as per time schedule as mentioned above.

Subject: Declaration of Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 – Clarification regarding formats to be used for filing returns under the Act.

The undersigned is directed to refer to this Department's DO letter of even No. dated 29th December, 2014 and the O.M. of even No. dated 13th January, 2015 regarding furnishing of information relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013, forwarding therewith copies of the Central Government's notifications dated 26th December, 2014 containing—

- (a) Amendment to the Lokpal & Lokayuktas (Removal of Difficulties) Order, 2014, for the purpose of extending the time limit for carrying out necessary changes in the relevant rules relating to different services from "three hundred and sixty days" to "eighteen months", from the date on which the Act came into force, i.e., 16th January, 2014; and
- (b) The Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Amendment Rules, 2014, extending the time limit for filing of revised returns (pl see proviso under sub-rule 2 of rule 3 of the principal rules) by all public servants from 31st December, 2014 to 30th April, 2015.
- 2. In this regard, it is clarified that :-
 - (i) The first return (as on 1st August, 2014) under the Lokpal Act should be filed on or before the 30th April, 2015:
 - (ii) The next annual return under the Lokpal and Lokayuktas Act, 2013 for the year ending 31st March, 2015 should be filed on or before 31st July, 2015; and
 - (iii) The annual return for subsequent years as on 31st March every year should be filed on or before 31st July of that year.
