shall be laid, as soon as may be after it is made, before the Legislative Assembly of Delhi, while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and if before the expiry of session immediately following the session of the successive sessions aforesaid, the Legislative Assembly agrees in making any modification in the rule or regulation, or the Assembly agrees that the rule or regulation should not be made, the rule or regulation shall thereafter have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule or regulation.

.28. Power to remove difficulties.—(1) If any difficulty arises in giving effect to the provisions of this Act, the Government may, by order published in the Official Gazette, make such provisions, not inconsistent with the provisions of this Act as appear to it to be necessary or expedient for removing the difficulty:

Provided that no such order shall be made after the expiry of a period of two years from the date on which this Act comes into force.

(2) Every order made under this section shall, as soon as may be after it is made, be laid before the Legislative Assembly.

परिवहन विभाग अधिसूचना

दिल्ली, 20 अप्रैल, 2011

सं. फा. 19(95)/परिवहन/सचि./2010/04.—जबिक ऐसा देखा गया है कि आपातकालीन वाहनों जैसे फायर ब्रिगेड वाहन एम्बुलेंस, पुलिस पेट्रोल वैन तथा दिल्ली सरकार के परिवहन विभाग के वाहनों को ऐसे समय जब ये आपातकालीन वाहन किसी सार्वजनिक नुकसान को रोकने या किसी आपातकालीन स्थिति पर जाने के लिए चल रहे होते हैं तो अन्य प्रकार के मोटर वाहन इनको खुला रास्ता नहीं देते।

और जबिक इन आपातकालीन वाहनों को सार्वजनिक व्यवस्था, सुरक्षा तथा बचाव कार्य को देखते हुए इन वाहनों को अपने गंतव्य पर समय पर पहुंचना आवश्यक होता है और इनको खुला रास्ता देना भी सनिश्चित किया जाना आवश्यक है।

इसलिए, मोटर वाहन अधिनियम, 1988 (1988 का 59) की धारा 2 के खंड (41) के साथ पठित धारा 115 द्वारा प्रदत्त शिक्तयों का प्रयोग करते हुए राष्ट्रीय राजधानी क्षेत्र दिल्ली के उपराज्यपाल ऐसा आवश्यक समझते हैं कि एम्बुलेंस, फायर इंजन, पुलिस पेट्रोल वैनों तथा दिल्ली सरकार के परिवहन विभाग के आपातकालीन वाहनों का अबाध आवागमन सुनिश्चित किया जाना चाहिए तथा दिल्ली/नई दिल्ली क्षेत्र में सार्वजिनक हितों की रक्षा के लिये इसके द्वारा आदेश देते हैं कि जिन सड़कों पर तीन या अधिक लेन हैं उनकी एकदम दायों लेन फायर ब्रिगेड, एम्बुलेंस, पीसीआर वैन, दिल्ली सरकार के परिवहन विभाग के वाहनों जैसे आपातकालीन वाहनों द्वारा आपातकालीन स्थित पर जाने के समय प्रयोग की जाएगी। ये आपातकालीन वाहन जब सायरन या बत्ती जलाकर आपातकालीन समय में एकदम दायों ओर की लेन का प्रयोग करेंगे तो उनको गुजरने का सर्वोपरि अधिकार होगा। सभी अन्य वर्ग के वाहन सड़क/गली में बायों और आकर एकदम दायों लेन का रास्ता खाली कर देंगे।

यह अधिसूचना 31 मार्च, 2012 तक वैध होगी।

TRANSPORT DEPARTMENT NOTIFICATION

Delhi, the 20th April, 2011

No. F. 19(95)/Tpt./Sectt./2010/04.—Whereas, it has been observed that emergency vehicles such as Fire Brigade vehicles, Ambulances, Police Patrol Vans and vehicles of Transport Department, Government of NCT of Delhi are not being provided free passage by other categories of motor vehicles while these emergency vehicles are being driven to prevent damage to the public or to attend to any emergency situation(s).

Whereas it is imperative for these emergency vehicles to reach their destination in time in the interest of public order, safety and security and to ensure free passage to these emergency vehicles.

Therefore, in exercise of the powers conferred by Section 115 read with clause (41) of Section 2 of the Motor Vehicles Act, 1988 (59 of 1988), the Lieutenant Governor of

the National Capital Territory of Delhi, on being satisfied that it is necessary to ensure the uninterrupted movement of Emergency Vehicles such as Ambulances, Fire Engines, Police Patrol Vans and vehicles of Transport Department, Government of NCT of Delhi and in the interest of safety of the general public in Delhi/New Delhi areas, does hereby, order that the extreme right lane on roads having three or more lanes will be used by emergency vehicles like Fire Brigades, Ambulances, PCR Vans or vehicles of Transport Department, Government of NCT of Delhi while they are attending emergencies. These emergency vehicles when using the extreme right hand lanes in emergency indicated by a siren and flashing of lights will have the overriding right of way. All other categories of vehicles will vacate the extreme right lane by moving to the left of the road/street.

This notification shall be valid till March 31, 2012.
