“Import of new motor cycles with engine capacity of 800 cc or more, by all categories of importers, including: (a) Individuals; (b) Companies and firms; or (c) OEMs (who have manufacturing and service network in India) will be exempt from the conditions at sl. No (2) (II) (c) of import licensing notes “. However, at the time of Customs clearance, an EC Type Approval Certificate / COP, of an accredited agency from any member state of EU, including a notarized English translation thereof, shall be furnished. This type approval shall stipulate that the vehicle to be imported meets the technical requirements of all relevant separate directives, as last amended and listed in EU directive 2002/24/EC. Such imported motorcycle shall meet the EURO III emission norms as defined in EU directed 2003/77/EC.

The accredited agency RDW Centrum voor voertuigtechniek en informatieve, Europaweg 205, Zoetermeer, Postbus 777, (Netherlands) has certified that the vehicle type **(LZT00B) Commercial Name VERSYS 1000** manufactured by Kawasaki Heavy Industries Ltd. P.O. Box- 16, 1-1, Kawasaki-Cho Akashi, 673-8666, Japan meets the technical requirements of all relevant separate directives(as last amended) to the directive 2002/24/EC. The sound level test and exhaust level test meets the base directive 97/24/EC, amending directive 2009/108/EC.

The approval is accorded subject to the responsibility of the manufacturer / importer for ensuring fulfillment of all the terms and conditions of Import licensing notes (9) of chapter 87, Schedule -I (imports) to the ITC(HS) Classifications of Export and Import items, 2004-09 as amended vide notification No. 62(E) (RE-20087) / 2004-09 dated 12th December,2007 issued by the DGFT, for homologation of imported vehicles and fitment of the same component, parts/ assemblies etc. which were produced before international accredited testing agencies at the time of submission of the vehicles for COF/Registration. Manufacturer should ensure that the vehicle is delivered fully build by them and no element of local body building is involved. **Further, the model and its variants will not be registered unless the manufacturer intimates the Ex-showroom price to the department.**

The authorized importer should enclose a certificate of origin and / or sales invoice issued by the original manufacturer in his name alongwith the bill of entry. Form-21 (sale certificate) and local sales invoice should also be issued by the importer / authorized dealer having a valid trade certificate. Rule 47(h) of CMVR will also be complied with.

All MLOs/ CMVI (Burari) are requested to accept the **Base Model – VERSYS 1000 two wheeler** – L3e, complying with BS-III mass emission standards manufactured by Kawasaki Heavy Industries, Ltd. P.O. Box- 16, 1-1, Kawasaki-cho Akashi, 673-8666, Japan subject to the compliance of provisions of Motor Vehicle Act, 1988 and rules made there under and the department's instructions/order issued from time to time in this regard.
