Sir/Madam,

I am directed to inform that at present gazette notification of Govt. of Delhi is printed in physical form for which departments send the hard copy of the gazette notification to this department and soft copy to Govt. of India press, Mayapuri, at email id may-gippr@nic.in

A system has been made operational in co-ordination with IT Department, Govt. of Delhi for the digital publication of gazette notifications of this Government. It has been decided that from 01.05.2016 gazette notification will be fully processed on digital platform and hard copy of gazette notification will not be accepted by General Administration Department and accordingly no hard copy of the notification will be sent to Govt. of India Press, Mayapuri, New Delhi.

It is therefore requested that all concerned may be directed to adhere the following steps for publication of gazette notification:-

- 1) Department/Organization should prepare gazette notification in Hindi (Krutl Dev font or Mangal font only) as well as in English which should be signed by the competent authority of the Department. Dispatch number and the date should be recorded on the Hindi and the English version of the gazette notification, as being done at present.
- 2) The aforesaid signed gazette notification should be scanned (viz PDF/JPEG/JPG/PNG) and saved as an image file.

- 3) Notification stated above at Point: 1 should be also saved in another file in word format, as being done at present.
- 4) Notification files as stated at point 2 and 3 should be mailed to gadegazette.delhi@gov.in While sending the mail name of the department, file no, dispatch no. and date of dispatch as mentioned in the gazette notification should be mentioned in the subject of the email.
- 5) Certificate as being prepared at present should also be scanned and sent along with the scanned copy of the notification stated at point 2. The officer signing the certificate should clearly mention his name, designation and mobile as well as office telephone number.
- 6) After receiving the Gazette Notification in the email id gadegazette.delhi@gov.in, given at Point: 4, GAD will examine whether the notification is in order or not; and will send a reply accordingly. The officer concerned of the department who had sent the gazette notification must check the email from which the notification was sent on same day for any corrective action, if required, as mentioned in the reply email of GAD.
- 7) From 01.05.2016 soft copy of gazettes should not be sent to Govt. of India Press, Mayapuri, at email id may-gippr@nic.in
- 8) Departments should download the published Gazette Notification from <http://egazette.delhi.gov.in> or Delhi government portal <http://delhi.gov.in> from 01/05/2016, GAD will not send any hard copy of printed gazette notification.
