

## CIRCULAR

Circular of even no. dated 16.09.2015 and reminder dated 01.10.2015, may be referred by the departments, whereby a request was made to link them MTNL landline office phones to the office building and Govt. servants to link their residential MTNL landline number to the residence building.

The progress on this account has been slow despite its usefulness. This linking will be very useful in providing timely help in the case of emergencies. Many departments are sending their MTNL landline numbers to GSDL to integrate, which is not a correct procedure. It is reiterated that the linking has to be done through the web based application the offices by themselves, hosted at http://gis.gsdl.org.in/callerlocation/. The Customer Account Number, (CA Number), which is available only in the bill, will also be required to authenticate the veracity of the landline number. The Govt. servants under the administrative control of the department may also please be persuaded to link their residence MTNL Landline numbers.

The departments are requested to link their MTNL telephone numbers by 31.12.2015 failing which the bills of telephone numbers which have not been linked, will not be processed with effect from January, 2016.
