Many departments are sending their MTNL landline numbers to GSDL to integrate, which is not a correct procedure. It is reiterated that the linking has to be done through the web based application by the offices themselves, hosted at <http://gis.gsd1.org.in/callerlocation/>. The Customer Account Number, (CA Number), which is available only in the bill, will also be required to authenticate the veracity of the landline number. The Govt. servants under the administrative control of the department may also please be persuaded to link their residence MTNL Landline numbers.
