CIRCULAR

Attention is invited toward Circular No.01/60/05/AC(W)/34594 - 34862 dated 04.04.2008 vide which provision of Rule 20 of CCS(Conduct) Rules, 1964 as applicable for DJB employees was brought into the notice of all the employees (copy enclosed overleaf).

As per the rule 20 of CCS(Conduct) Rules, 1964 "No Government Servant shall bring or attempt to bring any influence to bear upon any superior authority to further his/her interests in respect of matter pertaining to his/her service under Government."

Despite of above instructions issued, it has been observed that attempts are being made by some of the employees to bring in influence from non-official and other outside authorities for their service interest/matter in violation of the rules.

It has been viewed seriously by the competent authority and henceforth it has been decided that any such attempt would be considered as violation of CCS conduct Rule and would be dealt seriously.

Therefore, all the DDOs/Controlling Officers are once again requested to bring the above instructions to the notice of all the employees with the directions to take these instructions in proper perspective and not to give any occasion for initiation of disciplinary proceedings against them for violation of these instructions.


CIRCULAR

Rule 20 of CCS (Conduct) Rules, 1964 as applicable for DJB employees envisages that "No Government servant shall bring or attempt to bring any influence to bear upon any superior authority to further his/her interests in respect of matter pertaining to his/her service under Government."

2. In spite of the instructions issued in this regard from time to time it has come to notice that some employees resort to non-official and other outside influences to further their service interests in violation of the rules.

3. In future, attempts to influence officers regarding service matter or placement would be violation of the CCS (Conduct) Rules.


