Subject:- Revision of option for fixation of pay in the revised pay structure for persons promoted to the grade of Asstt. Accounts/Audit Officer (AAO) after 01/01/2006 - relaxation regarding.

Sir/Madam,


Several references have been received from various filed offices and individuals, who have been promoted to the grade of Asstt. Accounts/Audit Officer (AAO) after 01/01/2006, seeking permission to revise their option exercised earlier, for fixation of their pay in the revised pay structure from the date of their promotion to mitigate the disparity in their pay with respect to direct recruit probationers in the cadre of AAO.

2. The matter has been considered taking into account the anomalous situation in pay of the direct recruit and promotee AAOs and it has been decided to give one time relaxation for revision of the earlier exercised option for fixation of pay in the revised pay structure to the persons who have been promoted as AAO after 01/01/2006 from the date of their promotion to the cadre, if the option is more beneficial to them.

3. The persons desirous of revising their earlier exercised option may be permitted to revise the same within one month from the date of issue of this circular. No arrears shall be payable to them for the period from 01/01/2006 till the date prior to their promotion consequent upon fixation of pay in the revised pay structure from the date of their promotion as AAO and the excess pay and allowances drawn, if any, shall be adjusted/recovered in one lumpsum.
