Whereas, undersigned has been appointed as Administrator for the purpose of rehabilitation and resettlement of affected families under sub section (1) of section 43 and under signed has conducted a field survey of proposed acquired land on 26/04/2016, with revenue field staffs. Report shall be made on the basis of revenue record and field verification and shall cover following aspects as enlisted below:-

- a) Particulars of lands and immovable properties being acquired of each affected family.
- b) Livelihood lost in respect of land losers and landless whose livelihoods are primarily dependent on the land being acquired.
- c) A list of public utilities and government building which are affected or likely to be affected where resettlement of affected families is involved.
- d) Detail of the amenities and infrastructural facilities which are affected or likely to be affected where resettlement of affected families is involved.
- e) Details of any common property resources being acquired.

- f) List of affected families with Aadhaar number of its members, if available
- g) List of displaced families with Aadhaar number of its members, if available
- h) List of infrastructure in the affected area
- i) List of land holdings in the affected area
- j) List of trees, buildings, other movable property or assets attached to the land or building which are been acquired
- k) List of trades or businesses in the affected area
- l) List of persons belonging to the Scheduled Castes, or the Scheduled Tribes, the differentially-abled persons in the affected area

The public hearing and field survey shall be conducted on 17/06/2016 in the affected area in Village Bijwasan.
