CIRCULAR

Subject: Uploading the Admission Criteria and details of applicants in respect of Private Un-aided Recognized Schools for admission under Open Seats at Entry Level classes:-Session 2016-17.


Admission Schedule for Entry Level Classes(below six years of age) for open seats in Private Un-aided Recognized schools of Delhi for the session 2016-17 was circulated vide this Directorate's circular no. F.DE.15/Act-I/2013/5009-5020 dated 08.12.2015 vide which all the Private Un-aided Recognized schools were directed to upload the criteria adopted (including points for each criterion) for admission of open seats at Entry Level classes (other than EWS/DG category seats) for the academic session 2016-17 and also the details of children who apply for admission under Open seats and marks allotted to each of them by the school under their point system.

The schools who had not uploaded their admission criteria were again directed to upload the same vide order of even no. dated 22.12.2015. It has been observed that some of the schools have still not submitted the admission criteria to be adopted for the admission for the session 2016-17. Managers/HOS of all such school are hereby again directed to immediately upload the same on the departmental website **www.edudel.nic.in at the link through login ID and Password>>School Plant>>School Information>>Admission Criteria(2016-17) by 31.12.2015.**

Once the admission criteria is uploaded and the school start receiving applications from 01.01.2016, , it shall award the points to the applicant on the basis of Points System already decided and submitted to the Directorate. The details of the applicants shall be uploaded at the link in this regard available w.e.f. 01.01.2016 on the departmental website **www.edudel.nic.in at the link through login ID and Password>>School Plant>>>School Information>>>Details of Applicants under Open Seats (2016-17).**

All Deputy Directors of Education are directed to ensure that the said admission criteria and details of applicants are uploaded by all the schools concerned under their respective jurisdiction.

These instructions are issued for strict compliance by all concerned.
