Kindly refer to this office circular/letter No.F.DE 4(8)/(23)/E-IV/Lab.Asstt./2015/7419-7530 dated 03.11.2015 on the above subject vide which the last date of receiving/reaching the requisite applications/documents/particulars of Group-D employees in this office, was 31.12.2015. A copy of said circular/letter dated 03.11.2015 alongwith its Format is enclosed herewith for ready reference.

Now, in the interest of justice, it has been decided by the competent authority to extend the date of receiving/reaching the applications/ documents/particulars of Group-D employees in this office **up to 29.01.2016**. In any circumstances, no more extension will be granted after 29.01.2016.

All the HODs are requested to bring it to the notice of all concerned and the details/particulars of all the willing and eligible Group-D employees in the attached FORMAT (Hard copy as well as soft copy in EXCEL format) placing in the separate folder for each employee alongwith all the requisite information/documents as mentioned in the aforementioned circular/letter dated 03.11.2015, should be reached to the undersigned **by 29.01.2016 positively**. Further, to decide the eligibility, the cut-off date is 01.01.2015.

No individual application directly from employees will be entertained in any circumstances. Further, this Directorate will be unable to entertain application(s) received after **29.01.2016** and concerned department will be responsible for not including the name of such eligible employees in tentative eligibility list. It is reiterated that only the names of eligible group-D employees who are in the possession of necessary essential qualification as on 01.01.2015 may be sent to this office.

Subject : Regarding inviting the names of eligible Group-D employees for preparation of Tentative Eligibility List for promotion to the post of Laboratory Assistant in Directorate of Education, GNCT of Delhi.

Sir/Madam,

I am directed to inform that Directorate of Education, Govt. of NCT of Delhi, is considering the promotion of eligible Group-D employees of Govt. of NCT of Delhi to the Group-C post of Laboratory Assistant in the Pay Band of Rs.5200-20200/- with Grade Pay Rs.2400/-.

You are requested to bring it to the notice of all the concerned and furnish the details of **all the willing and eligible Group-D employees** in attached FORMAT (Hard copy as well as soft copy in EXCEL format) to the undersigned. The concerned official(s) should have completed 03 years service as regular employee and should possess(es) **“Matriculate or equivalent/Higher Secondary with Science (Physics & Chemistry with Practical or physics, chemistry & biology with Practical) and employees who are matriculate or equivalent/Higher secondary without science : provided they have successfully undergone a three months Orientation Course in Science conducted by the Directorate of Education”**. Further, to decide the eligibility, the cut-off date is 01.01.2015.

The particulars in prescribed format along with separate folder for each employee containing the following, should be reached to the undersigned by **31.12.2015 positively**

:-

- (i) Attested copies of educational qualification (Mark Sheet & Certificate).
- (ii) Attested copies of SC/ST & PH Certificate (where applicable).
- (iii) Work & Conduct Report, Vigilance Clearance Report & Integrity Certificate, separately.
- (iv) First page of service book showing the Name, DOB etc. of employee concerned.
- (v) Copy of concerned page of service book containing the entry of 'Date of absorption/redeployment', in case the employee is absorbed/redeployed in GNCT of Delhi
- (vi) Copy of concerned page of service book containing the entry of **“Date of Appointment” of the employee clearly.**
- (vii) The Department concerned may ensure that the employee(s) concerned possess (es) essential qualification as per Recruitment Rules of Laboratory Assistant.

Further, the following may also be brought to the notice of all concerned that –(i) after promotion to the post of Laboratory Assistant, no request for repatriation to his/her parent department to his/her parent post i.e. Group-D, will be allowed in any circumstances in this Directorate (ii) if, after giving promotion to the post of Laboratory Assistant, anyone does not join the duty in this Directorate, he/she will be debarred for further five years for promotion to the post of Laboratory Assistant. (iii) the old Tentative Eligibility list(s) will not be given any weightage in this process.


It is brought to the notice of the Department concerned that the name of such officials of Group-D who were selected & given promotion as Laboratory Assistant in the year 2014-2015 but they did not join the duty as Laboratory Assistant in this Directorate due to unwillingness/refusal of promotion, may not be sent this year for promotion to this office.

It is brought to the notice that as per Notification dated 29.07.2013 in the Gazette of India, issued by Ministry of Social Justice and Empowerment, the post of Laboratory Assistant has not been identified as suitable for Visual Handicapped/Disabled person.

No individual application directly from employee(s) will be entertained in any case. Further, this Directorate will be unable to entertain application(s) received after 31.12.2015 and concerned department will be responsible for not including the name of such eligible employees in tentative eligibility list. It is reiterated that only the names of eligible group-D employees who are in the possession of necessary essential qualification as on 01.01.2015, may be sent to this office.
