Subject: Compliance of recommendations of JADSC -regarding

Sir/Madam,

Please refer our earlier orders even nos. DE.15/Act-1/F.H./JADSC /2015/4277-85 , dated: 20.10.2015 , DE.15/Act-1/F.H./JADSC /2015/26998-270005 , dated: 21.10.2014 and DE.15/Act-1/F.H./JADSC /2015/7177-81 , dated: 28.02.2013 on the subject cited above , whereby all unaided and recognised private schools identified for refund excess fee by Justice Anil Dev Singh Committee in its interim reports were directed to refund the excess fee to the parents of children with the direction to all DDE(Districts) to submit the compliance report within a month time.

As per the reports received from District DDE's after the last order dated 20.10.15 merely 43 schools out of 472 identified to refund excess fee in JADSC's eight interim reports have complied with the aforesaid orders of Directorate of Education partially or wholly.

Further the Directorate of Education is not authorised to review the recommendations of the Justice Anil Dev Singh Committee ,therefore, all unaided and recognised schools were advised vide circular number .DE.15/Act-1/F.H./JADSC/2015/29510-514 , dated 18.03.2015, not to submit any representation in this regard to the Directorate of Education.

Now all District Dy. Directors of Education are directed to issue necessary instructions to comply with the recommendations of the JADSC, to all defaulting unaided recognised schools falling in their jurisdiction identified by committee to refund excess fee and submit the status report within a period of 15 days.

SUBJECT: COMPLIANCE OF JADSC'S EIGHT INTERIM REPORTS.

In continuation of orders even Nos. DE.15/ACT-I/F. H./JADSC/2014/26998-270005 , dated 21.10.2014 and DE.15/ACT-I/F. H./JADSC/2013/7177-81 , dated 28-02-2013, the committee constituted by Hon'ble High Court of Delhi in the matter of W.P. (C) No.7777/2009 titled "Abhibhvak Maha Sangh and Ors V/s Govt. of NCT of Delhi" , has submitted eight interim reports to be implemented by the manager/Principals of schools as per the said reports.

These eight Interim Reports' are available on the homepage (in scrolling window) of www.edudel.nic.in, the official website of the Directorate of Education, GNCT of Delhi.

All 472 schools that have been identified by the committee in its eight reports to refund excess fee charged ,are hereby directed to comply with the said reports within a period of 15 days and to submit compliance report to the concerned District authorities in the following manner:

 First, the schools that have charged excess fee to implement 6th CPC but have not implemented the same are directed to make the payments to its staff as per 6th CPC, out of excess fee collected, with 9% interest, without further raising any fresh demand from the parents/students.

 And if after implementing the 6th CPC in the school, there still remains excess money charged from the students / parents by such school, it shall be refunded to the children / parent concerned.

SUBJECT: COMPLIANCE OF JADSC'S FIVE INTERIM REPORTS

In pursuance of orders dated 12.08.2011 of Hon'ble High Court of Delhi in the matter of W.P. (C) No.7777/2009 titled "Abhibhvak Maha Sangh and Ors V/s Govt. of NCT of Delhi", a Committee comprising of three members was constituted vide Directorate of Education's Notification No.15(110)/DE/2011/5429-38 dated 23.09.2011 which is headed by Sh Anil Dev Singh, Chief Justice (Retd.), Rajasthan High Court. This committee was constituted for the purpose of examine the records and accounts of all the unaided recognized schools of Delhi, to check whether the fee hike by each school while implementing the recommendations of 6th Central Pay Commission was justified or not.

The said Committee has submitted 05 Interim Reports in the Hon'ble High Court of Delhi till date and the Hon'ble High Court of Delhi vide orders dated 24/01/2014, has permitted Government of NCT of Delhi to implement the recommendations made in the said reports by the committee as these reports are conclusive and binding on all Unaided Recognized Private Schools of Delhi.

These 'Interim Reports' are already available on the homepage (on scroll list) of www.edudel.nic.in, the official website of the Directorate of Education, GNCT of Delhi. The action is now required to be taken by all Unaided Recognized Private Schools of Delhi on these reports in order to implement the same in letter and spirit.

Now, therefore, the Managements/Principals of those 330 (Three hundred thirty) unaided Recognized Private Schools which have been identified by the said committee in already published five 'Interim Reports.Reports' to return the excess fees charged from the students / parents are, hereby, directed to

implement the recommendations made therein for each individual school by said committee, within a fortnight, from the date of issue of this circular in the following manner –

- First, the schools that have charged excess fee to implement 6th CPC but have not implemented the same are directed to make the payments to its staff as per 6th CPC, out of excess fee collected, with 9% interest, without further raising any fresh demand from the parents/students.
- And if after implementing the 6th CPC in the school, there still remains excess money charged from the students / parents by such school, it shall be refunded to the children / parent concerned within the fortnight.

This issues with the approval of Competent Authority.

ORDER

Whereas, as per the First Interim Report dated 23.08.12 submitted by Justice Anil Dev Singh Committee constituted by Hon'ble High Court of Delhi for review of fee hike, Managements of 64 unaided recognized schools of Delhi have been found to have increased the fee without any valid reasons and collected excess fee from the students.

And Whereas, vide Show Cause Notices dated 16/01/2013, the Managers of the said 64 schools were directed to show cause in writing within 3 days as to why an order should not be passed to refund excess fee charged from the students of the school along with @ 9% interest from the date the excess fee was collected till date.

And, whereas, arguments put forth by all such schools have been found to be lacking substance and/or are contrary to the observations of Justice Anil Dev Singh Committee.

Now, therefore, the Managers/HOSs of these 64 schools (Listed placed below) are hereby directed to complete the process of refund excess fee charged from the students of the school with 9% interest from the date the excess fee was charged till date as proposed by Justice Anil Dev Singh Committee within 7 days, if not already done so, and submit compliance report directly to Act-1 Branch, Room No.-229, Old Sectt. Delhi under intimation to the concerned DDE failing which action for withdrawal of recognition would be initiated against the school as per the provisions of Section 24(4) read with Rule 56 of the DSEAR, 1973, without any further correspondence.

Whereas in pursuance of orders dated 12.08.2011 of Hon'ble High Court of Delhi in the matter of W.P.(C) No. 7777/2009 titled "Abhibhavak Maha Sangh" and Ors V/s Govt. of NCT of Delhi", a Committee named as Justice Anil Dev Singh Committee (JADSC) comprising three members was constituted which is headed by Sh. Anil Dev Singh, Chief Justice (Retd.). This committee was constituted for the purpose of examining the records and accounts of all the unaided recognized schools of Delhi, to check whether the fee rike by each school, while implementing the recommendations of 6th Central Pay Commission, was justified or not.

Whereas JADSC has submitted 07 Interim Reports till date whereby total 494 unaided and recognized schools have been identified to return the excess fee charged from the students /parents. These Interim Reports are page of department already available the home on www.edudel.nic.in .

Now many of the aforesaid 494 unaided recognised schools aggrieved by the recommendations of the Justice Anil Dev Singh Committee, submitting the representation to the Directorate of Education to review the recommendations of committee. As the Justice Anil Dev Singh Committee has been set up by Hon'ble High Court , the Directorate of Education is not authorised to review the recommendations made by the Committee in r/o unaided recognized private schools of Delhi.

Therefore HOS/Manager of the unaided recognized private schools of Delhi are hereby advised not to submit any representation to Directorate of Education for reviewing the recommendations of JADSC made in respect of their schools.
