PUBLIC CIRCULAR

The Directorate of Education had been awarded a contract to M/s Computer Clinic India Pvt. Ltd. in June-2012, for deployment of 500 I.T. Assistant in Govt. Schools. The contract period was initially for one year i.e. 01/07/2012 to 30/06/2013 and extended upto 31/07/2014 in accordance of approval of Finance Department, Govt. of NCT of Delhi, time to time.

When the contract was awarded to the M/s Computer Clinic India Pvt. Ltd. many representations / complaints / grievances were received in this office regarding Demanding / Charging money from I.T. Assistants by M/s CCIPL or it's representatives.

In this regard, M/s CCIPL had been submitted a reply vide their letter No. CCIPL/Doedn./2012-13 dated 02/07/2012 vide which they had explained as follow: **“being a safe guard, the amount has been charged on-account of Registration & Training Charges (non-refundable) and Security Deposit (refundable, subject to deduction /penalties if any levy by the department)”. The details of Rs.12000/- is as (Rs.500/- registration fee + Rs.1500/- training charges + Rs.5000/- Absent fee + Rs.5000/- Transfer fee).**

The said contract has been over on 31/07/2014 and all the dues of agency had been released by the department. And, when the payment for the month of June-2014 and July-2014 was processed a penalty amount of Rs.77,800/- which was deducted on account of **“absent and no I.T. Assistant”** from the payment of agency.

After consideration request of M/s CCIPL, the amount of Rs.77,800/- was released to M/s CCIPL which was deducted on a/c of “absent and no I.T. Assistant” after approval of Director of Education (as per list of candidates/schools enclosed). M/s CCIPL has been directed to release the same to the respective IT Assistants and submit documentary proof to the department.

M/s Computer Clinic India Pvt. Ltd. has stated vide their letter No. Ref: CCIPL /DOED/2015/1229 dated 29/12/2015 that they have released security deposit to all the IT Assistants who were deployed by them, and submitted that in case of any claim in future the same will be cleared after verification.

M/s CCIPL has also stated vide their letter no. Ref: CCIPL /DOED /2015 1229-1 dated 19/01/2016 that they have released security deposit to all the IT Assistants and further submitted that they have also released the penalty amount for the absent during the June-2014 & July-2014 period that was released later by the department.

In view of position explained above, all the respective I.T. Assistants are hereby informed that if any person has any issue regarding Security Deposite and penalty deduction for month of June & July-2014(as per list) may be contacted to concerned agency i.e.




