CIRCULAR

Sub: Further extension of last date for admission of EWS/DG Category Students selected through computerized Draw of Lots in Private Unaided Recognized Schools of Delhi at Entry Level Classes for the session 2016-17.

It has come to the notice that most of the Private Unaided Recognized Schools have not completed the admission process of EWS/DG Category Students selected through computerized Draw of Lots at Entry Level Classes for the session 2016-17 in spite of granting extension of time up to 29/02/2016.

In order to ensure the admissions of EWS/DG category in Private Unaided Recognized Schools, the last date for granting admissions is hereby further extended up to 18/03/2016 in continuation of this Directorate's Circular No.DE/15/Act-I/08/155/2013/6754-6760 dated 22/02/2016.

Accordingly, all the Private Unaided Recognized Schools concerned are hereby directed to complete the admissions formalities up to 18/03/2016 and upload the details of reporting/admission/rejection etc. by 21/03/2016 as per the option available at the link already communicated through our previous circulars dated 12/02/2016 and 26/02/2016. If the school does not upload the details of reporting/admission/rejection etc. by 21/03/2016, the remaining seats shall be treated as vacant seats and the process to fill up these vacant seats shall be made by the department in the second round. The date for second round of admission will be notified later.
