Subject: - Declaration of results of various classes

Sir/Madam,

On the subject noted above, it is informed that Maxfort School Parents Association vide their representation dated 22/03/2016 have made complaint raising the following issues against the Maxfort Schools running in Pitampura and Rohini.

- (i) The school at Parwana Road, withheld results of the children, on 19/03/2016, of classes I- III (Maxfort School, Parwana Road, Pitampura, Delhi 110034, Recognized School from classes I - VIII) and only on written undertaking from parents that they will pay illegally enhanced fees they gave results, that too, not to all of them, a lot of parents have not been given results till date.
- (ii) The school principal, teachers, and admin staff have been constantly threatening parents over the phone and with notices that the results of their wards will not be given to them, if we parents do not give in to their illegal and arbitrary demands of hiked fees.
- (iii) The results of classes IV–VIII (PARWANA ROAD) are due on 26/03/2016 and of Classes, Nursery to XII (ROHINI) are due on 28/03/2016.
- (iv) DOE Orders of 16/04/2015, regarding Donation Refunds have still not been compiled by the school.

The matter was examined and it is observed that Maxfort Schools, Rohini and Pitampura, Delhi have not refunded the amount collected from the parents as donation/capitation fee at the time of granting admissions to their wards as ordered by the department vide order dated 16/04/2015 and 08/09/2015. Further, it is held that on the alleged non payment of hiked fee by the parents to the school, the Maxfort schools have struck off the names of the students and withhold the issuance of admit cards to the students appearing for the Board examinations, on the intervention of the department, the school has readmitted, the students and issued admit cards to the students concerned. Further, it is found that Maxfort School Parents Association vide their representation dated 24/11/2015 addressed to Hon'ble Chief Minister, Delhi inter alia alleged that Maxfort Schools are indulged in illegal transaction of huge sums of money to fake companies and individuals, illegal transfer of funds from collection accounts of schools to different trusts/societies, estimated amount is over 50 Crores till date, Money Laundering through misappropriation of cash, making payments from school payment accounts in Crores, to vendors for the services/materials and also collecting the same amount from parents in cash etc.

Matter of alleged illegal transactions of huge sums of money to fake companies, individuals and illegal transfer of funds has been referred to Economic Offence Wing of Delhi Police vide this Directorate's letter dated 22-03-2016 to register a case and take necessary action in the matter under intimation to this Directorate.

Since the matter of transfer of crores of funds from the school account to other Trusts/Societies/companies are to be investigated by EOW, Delhi Police, therefore, the management of Maxfort School is hereby directed to comply with the following directions:-

- (i) To refund the donations/capitation fee charged from the parents while admitting their ward as directed to the school vide order dated 16/04/2015 & 08/09/2015.
- (ii) Not to demand any arrears from the parents and to declare the results of various classes at pre-determined dates unconditionally without insisting them to pay the arrears /hiked fees.
- (iii) To utilize the reserve fund available with the school account as well as DRF account and revert back the amount in the school account, transferred to the any societies/trust/companies, if any as alleged, and meet out the expenditure of the school till the decision of the case registered in Economic Offence Wing of Delhi Police.

Non-compliance of the order shall be viewed seriously.

This issues with the prior approval of the Competent Authority.
