Boys—50, 54, 58, 62, 66, 70, 74, 78, 82 & 82+

Girls—44, 48, 52, 56, 60, 64, 68 & 68+

1. Original Passport(s) valid upto six months from the date of closing of the said championship.
2. 5 Passport size photographs (with white background) for VISA.

4. Copy of School-ID.
5. Original NOC(No objection certificate) from parents, Non-Judicial Paper (of parents only)
6. Bank statement (of parents) of last six months, duly attested by banker.
7. Copy of PAN card of both the parents.
8. Copy of death or divorce certificate (In case of single parent).
