

The terms & conditions of appointment are as under:-

1. The appointment can be terminated at one month notice from either side.

2. They will not be entitled to the facilities like reimbursement of medical expenses and Leave Travel Concession.
3. The contract appointment does not bestow any right upon the coach for regular appointment in Department of Education.
4. They will make liaison with concerned PWD (Civil & Electrical) Division, MCD. Delhi Police etc for obtaining the license.
5. Once the swimming season is over, they will impart specialized coaching and training to his/her school students' swimmers at Dr. Shyama Prasad Mukherjee Swimming Pool, after obtaining the permission from them.
6. They will take coaching camp for the participation of Delhi State contingents in various National School Games, Rajiv Gandhi Khel Abhiyan and National Sports Festival for Women and other various National and International tournaments.
7. They will lead Delhi State contingents in various National School Games, Rajiv Gandhi Khel Abhiyan and National Sports Festival for Women and other various National International tournaments.
8. They will render their services in organization of National School Games w.e.f. 2nd January to 9th January in Delhi and its preparation from 15th December onwards, or any other dates decided by the Government
9. They will work under the overall supervision of the Head of the school. Wherever the school is double shifted, then their engagement in the morning session will be controlled by Head of the School of the morning shift and evening session will be controlled by Heads of the School of the evening shift.
10. Once the swimming session is over, they will work under the overall supervision of the Head of School. In case of double shifted schools, female swimming coach will work in the morning shift school and male swimming coach will work in the evening shift school.
11. The total working hours per day will remain the same throughout the contract.
12. The duty timings will be from 6.00 A.M. to 9.30 A.M. and 3.30 P.M. to 7.15 P.M. six days a week (except Sundays, 2nd Saturday, National Holiday & Gazetted Holidays).
13. The payment will be made @Rs.23,220/- (Rs. Twenty three thousand two hundred twenty only) per month consolidated.
