The terms & conditions of appointment are as under:-

1. The appointment can be terminated at one month notice from either side.
2. They will not be entitled to the facilities like reimbursement of medical expenses and Leave Travel Concession.
3. The contract appointment does not bestow any right upon the coach for regular appointment in Department of Education.
4. They will accompany the respective school teams and school children of the school for participating in inter-zonal and other sports tournaments.
5. They will make aware the students with the first-aid techniques.
6. They will render their services in organization of National School Games w.e.f. 2nd January to 9th January in Delhi and its preparation from 15th December onwards, or any other dates decided by the Government
7. They will organize general physical activities for all the school students for their further development in athletics, football, volleyball and badminton etc.
8. They will work under the overall supervision of the Head of the school. Wherever the school is double shifted, then their engagement in the morning session will be controlled by Head of the School of the morning shift and evening session will be controlled by Heads of the School of the evening shift.
9. Once the swimming session is over, they will work under the overall supervision of the Head of School. In case the double shifted schools, female swimming life guard will work in the morning shift school and male swimming life guard will work in the evening shift school.
10. The total working hours per day will remain the same throughout the contract.
11. The duty timings will be from 6.00 A.M. to 9.30 A.M. and 3.30 P.M. to 7.15 P.M. six days a week (except Sundays, 2nd Saturday, National Holiday & Gazetted Holidays).

12. The payment will be made @Rs.15,123/-(Rs. Fifteen thousand one hundred twenty three only) per month consolidated.
