CIRCULAR

Subject: Updation of status of EWS/DG category students allotted through computerized draw of lots for admission at entry level of the Private Unaided Recognized Schools of Delhi for the session 2016-17.

Directorate of Education had conducted two adjustment rounds and second round of computerized draw of lots for admission of EWS/DG category candidates at entry level of the Private Unaided Recognized Schools of Delhi for the session 2016-17 and accordingly names of the successful candidates were forwarded online to the concerned school with the direction to admit the child as per the department guidelines and update the status of each and every candidate online on the special module generated for EWS/DG category admission on the department website.

The last date of admission for the EWS/DG category candidates allotted through second round of computerized draw of lots was 15/06/2016. But till date, many of the schools have not updated the status of each and every candidate online on the department module.

To take necessary decision on the remaining vacant seats of EWS/DG category at entry level of the Private Unaided Recognized Schools for the session 2016-17, exact number of remaining vacancies is to be calculated.

Therefore, all the Private Unaided Recognized Schools concerned must give admission to the EWS/DG category students allotted during adjustment rounds and second round of computerized draw of lots latest by 30/07/2016 and accurately update the status of each and every EWS/DG category candidate latest by 05/08/2016. The module for admission of EWS/DG category for the session 2016-17 will be locked at 6:00 PM on 05/08/2016 for calculating the remaining vacancy of EWS/DG category. The entry at the closing date will be considered as final and the concerned school will be held responsible for any lapses in this regard.

Further, all the Private Unaided Recognized Schools who participated in the process of online admission of EWS/DG category students for the session 2016-17 must fill the total number of students admitted (admissions done till 30/07/2016) at entry level of the school under General category in the module specially generated for this purpose on the departmental website
