Sub: Issue of Revised Tentative Eligibility List of Group-D employees of Departments of GNCT of Delhi, for promotion to the post of Laboratory Assistant in the Directorate of Education, GNCT of Delhi.

Sir / Madam,

Kindly refer to this office Letters/Circulars No.F.DE.4(8)/23/E-IV/Lab Asstt./2015/4113-238 dated 29.04.2016 vide which objections, if any were invited in respect of eligible Group 'D' employees of GNCT of Delhi, with clarification on the discrepancies noted in the remarks column of the list for preparation of Tentative Eligibility List for promotion to the post of Laboratory Assistant in the Directorate of Education, GNCT of Delhi. In this connection, it is stated that desired clarifications have still not been received in respect of many eligible Group 'D' officials.

In this regard, I am directed to forward herewith a copy of Revised Tentative Eligibility list and request you to kindly remove the discrepancies/shortcomings mentioned in the remarks column of the list and also circulate it amongst all officials concerned working in your Department/Office at the earliest and objections, if any, raised by them whose name appears in the List, may be sent to this office **by 31.07.2016** along with the concerned page of the Revised Tentative Eligibility List in which their names appear. If no objection/request for removing the discrepancies/shortcomings is received within stipulated period, it will be assumed that they have nothing to say in this regard and the Revised Tentative Eligibility List will be treated as final after removing the objection, so received. The old tentative eligibility list(s) has/have not been given any weightage in the process. All Concerned Group 'D' employees are advised to check their particulars and submit the objection(s), if any, to remove the discrepancies/shortcomings as mentioned against their names in the List through their concerned Competent Authority along with attested copy of supporting documents, **by 31.07.2016** positively. It may also be noted that employees unwilling to accept promotion may also inform their HODs about the same which may be forwarded to this Branch immediately through their HODs.

It is further reiterated that HODs concerned will be held responsible if eligibility of any official is rejected at any stage due to furnishing/forwarding of incorrect information/ service particulars by their Departments and this Directorate in no way will be held responsible for rejection of such incomplete/incorrect information/service particulars. It is further requested to ensure that all particulars shown in the Revised tentative list of respective employee is correct as per your office records/service book etc. specially date of appointment, date of birth & date of acquiring essential qualification, if any discrepancies found in particulars, it may invariably be intimated within stipulated period for taking further necessary action in the matter. It is made clear that objections received after the cut off date will not be entertained by this Directorate and no further extension for raising objections will be granted.

It is made further clear that in case, it comes to the notice of this office at any stage that the requisite educational qualification has been acquired by the official concerned from such Board/Institution which is fake or not recognised, the eligibility of the official concerned will be rejected by this office and even, such official is given promotion to the post of Laboratory Assistant, his promotion will be cancelled without giving any notice to the official concerned and the Department concerned as well as Group-D official concerned will be responsible for the same.

While every care has been taken in preparing the Revised tentative eligibility list, Directorate of Education reserves the right to rectify errors and omissions if any at any stage.
