CIRCULAR

Subject:- Updation of status of EWS/DG category candidates allotted during adjustment rounds & second round of computerized draw of lots and filling the online information regarding the General Category admission at entry level classes for the session 2016-17

Directorate of Education vide circular dated 20/07/2016 & 28/07/2016 had issued directions to all the concerned Private Unaided Recognized Schools of Delhi to accurately update the status of each and every EWS/DG category student allotted during adjustment rounds and second round of computerized draw of lots latest by 05/08/2016.

Also, all the Private Unaided Recognized Schools who participated in the process of online admission of EWS/DG category were given direction to fill the total number of students admitted (admission done till 30/07/2016) at entry level of the school under General Category in the module specially generated for this purpose on the department website latest by 05/08/2016.

Despite issuing various circulars and directions by the Department, many schools have failed to update the status of each and every EWS/DG category student on the department module and fill the information regarding the General Category admission at their entry level on the module specially generated for the purpose.


Therefore, **all the Private Unaided Recognized Schools are given last and final opportunity to accurately update the status of each and every EWS/DG category student allotted to them during adjustment rounds & second computerized draw of lots and fill the information regarding the General Category admission at their entry level online on the specially generated module latest by 16/08/2016 till 6:00 PM.**

Thereafter, the EWS/DG category admission module of this Directorate shall be locked and the exact number of remaining vacancies shall be calculated on the basis of records available on the module on 16/08/2016 at 6:00 PM. The concerned school shall be liable/responsible for any discrepancy in the entries available on the module at that point of time.

Further, district DDEs vide circular dated 28/07/2016 were directed to contact the candidates under "Not Reported" category (randomly atleast 50%) and to verify whether the parents are really not willing for admission of their ward in the allotted school or school has done it with any mala-fide intention and also to ascertain whether the rejected cases are justifiable as per department guidelines. **Therefore, district DDEs must submit the report in this regard latest by 16/08/2016 and ensure that all the concerned school managements fill the requisite information online by the prescribed time limit.**


