CIRCULAR

Subject:- Verification of the data filled online by the Private Unaided Recognized Schools in respect of EWS/DG category candidates allotted during adjustment rounds & second round of computerized draw of lots at entry level classes for the session 2016-17

Directorate of Education has conducted two adjustment rounds and second round of computerized draw of lots for admission of EWS/DG category candidate at entry level of Private Unaided Recognized Schools of Delhi for the session 2016-17. All the concerned schools were directed to update the status of each and every EWS/DG category students online on the module specially designed for the same.

As per the data filled online by the concerned schools (as on 10/08/2016), out of total 5912 allotted candidates, around 3487 candidates are under "Not reported" category. All the District DDEs have already been directed to contact the candidates under "Not reported" category and to verify whether the parents are really not willing for admission of their ward in the allotted school or school has done it with mala-fide intention. In case, the applicant under "Not Reported" category is willing to take admission in the allotted school, then District DDE must ensure the admission of the applicant in the concerned school. **District DDEs are hereby directed to submit the report in this regard latest by 16/08/2016 for perusal of the Competent Authority.**

Also, 234 candidates have been kept under "Inwaiting" category and 120 candidates are kept under "Rejected" category by the concerned schools. "Inwaiting" option was provided to the schools in case the seats of General Category students are not filled as per the vacancy notified by the schools. As per the provision, after every three admissions under open seats, the fourth admission shall be granted to the EWS/DG category student by the Private Unaided Recognized Schools. **Therefore, all the District DDEs are directed to verify whether the students kept under "Inwaiting" category are as per department guidelines or not. Also, District DDEs must verify the reasons of rejection provided by the concerned schools are justifiable as per department guidelines.** In case of any discrepancy in these categories, the concerned District DDE shall issue necessary direction to the concerned school management for rectification of the same.

District DDEs can check the details of the students/applicants allotted to the schools of their concerned district on the departmental website through the link:- *School Plant -> EWS -> EWS/DG Admission Report (2016-17) 2nd Lottery*. Thereafter, by clicking on the School ID, the status of the EWS/DG category students updated by the concerned school can be checked and after that by clicking on the Registration ID, the online application form filled by the applicant can be seen.

Further, regarding the cases of "Not Reported", "Rejected" and "Inwaiting" candidates, the concerned DDE District will be responsible for the reliability and efficacy of the verification exercise.
