CIRCULAR

Under Section 4 of Right to Education, 2009 there is a provision of Special Training for Out of School Children either in the school premises or a safe place available with the NGO. First of all those children will be enrolled in the regular school and they will be given ID or admission number and after that they will be given special training at the special training centres. The period of training will be from 03 months to 2 years for Out of School Children.

The following NGOs and Madarsas/Maqtbas have been empanelled by SSA for the year 2016-17 for opening of STCs in r/o the District mentioned against each. The school (Govt./Govt. aided/MCD/NDMC/DCB) should enroll the identified Out of School Children and provide I.D./admission number to them. These children will study at STC & will be mainstreamed within a period of 3 months to 2 years as per RTE ACT 2009.

After imparting special training for the said period in their school premises run by the Directorate of Education/MCD/NDMC/DCB or the space available with NGO, the children will be mainstreamed in their age appropriate class after having been assessed by SCERT/DIET/HOS. The assessment tests should be conducted by the NGOs frequently in co-ordination with SCERT/DIET's & HOS and consolidated report shall be submitted by the concerned HOS/NGOs to the SSA HQ regularly.
