Director/Head, School Health Scheme, Directorate General of Health Services, Department of Health and Family Welfare, GNCTD vide e-mail dated 14-10-2016 (copy enclosed for ready reference) requested to supply the data of the private schools and the number of children enrolled with them from class 6th to 12th. For this purpose, DGHS will organize trainings in schools and establish supply chain management and set up ERS to deal with minor side effects of medication, if any

Therefore, all the Heads of Private Unaided Recognized Schools of Delhi, who desire VOLUNTARILY to implement National De-Worming Programme in their schools, are hereby advised to contact Dr. Anil Kumar Gupta MD (Pediatrics), Addl. Director/Head, School Health Scheme, Directorate General of Health Services, Department of Health and Family Welfare, GNCTD through e-mail or phone (given in their letter dated 14-10-2016, annexed herewith) and provide the data of enrolment of students of class VI to XII in their schools to them and make necessary arrangements for training session in consultation with the said authority.
