CIRCULAR

Sub: Online entry of EWS & DG category students for the academic session 2016-17 for Reimbursement of per child expenditure under the provisions of RTE Act, 2009.

All Heads of unaided recognized schools of Delhi (under DOE/MCD's/NDMC/DCB) are hereby directed to submit the details of students admitted under EWS & DG category during 2016-17 session, in the online module using school login ID & password at link **School Plant=> EWS Reimbursement 2016-17** in the web portal of this Directorate (www.edudel.nic.in) by using Internet Explorer. Information against all items must be filled with due care and no item shall be left blank. Information shall be submitted from **1st Dec., 2016 to 31st Dec., 2016**. **Printout of the online report** duly certified by HOS shall be submitted by 10th January, 2017 to the DDE (zone) concerned.

2. The details of EWS/DG category students admitted through online process during 2016-17 will automatically be migrated to this reimbursement module. However, HOS shall confirm the current status of students appearing in the module. Likewise data of EWS & DG students entered during 2015-16 will also be shifted to the 2016-17 module with the option to upgrade the class of study and confirmation of continuation in the school.
3. The concerned DDEs (zone) shall conduct inspection to physically check the status of data entered in the online reimbursement module. Thereafter requisite approval shall be given online for further allocation of budget by Planning Branch and thereafter issue of sanctions by DDE's concerned. In the event of variation between the entered data and the status found through physical inspection, data submitted shall be rejected and Pvt. Unaided school will be required to correct and re-submit the same in the online module.
4. Private unaided schools of MCD's (North DMC, South DMC & East DMC) /NDMC/DCB shall submit data online and DDEs(Edu.) / ADEs(Edu.) of concerned local bodies are advised to forward the data submitted by private un-aided schools in hard copy form duly certified to the Directorate of Education to process for reimbursement.
5. The reimbursement towards admissions of EWS/DG category under RTE Act, 2009 will be made as per the rates approved by Finance Deptt. i.e Rs.1598/- per month/student for the session 2016-17.
6. In case of pvt. unaided schools on Govt. Land, reimbursement shall be allowed only up to 5% out of the 25% admissions of EWS & DG category students. However, in case of pvt. unaided schools on private land reimbursement is made towards all the EWS & DG category students.
