Department of Administrative Reforms GNCTD has been repeatedly writing to all Departments of GNCTD for ensuring compliance of section 4 of RTI Act. Letters F.13/1/2013/AR/4928-6088/C dated 13.05.2013 and F.13/1/2013/AR/869-1029/C dated 17.01.2014 and dated 01.01.2016 issued by Deputy Director (AR) of Department of Administrative Reforms (Government of NCT Delhi) were sent to your Department for taking cognizance and subsequent action on Office-Memorandum No.1/6/2011-IR dated 15.04.2013 from Department of Personnel & Training (Government of India) regarding implementation of sue-motto disclosure under section 4 of RTI Act 2005. But it is observed that many departments of Government of NCT Delhi have not yet taken steps for compliance of the said DoPT Office-Memorandum No.1/6/2011-IR dated 15.04.2013.

Now in view of directions by Hon'ble Delhi High Court, it is necessary that urgent steps may be taken for compliance of su-moto disclosure under Section 4 of RTI Act, 2005. Compliance-report on sections 4, 6 and 26 of RTI Act, 2005 may be urgently communicated Department of Administrative Reforms, GNCTD latest by 05.08.2016 so that directions of Hon'ble Delhi high Court may be complied in time.

This may be given top priority.
