Sub: Minutes of Meeting regarding payment of Wages to Contractual/ Outsourced Workes.



Accordingly, a list of defaulting departments is enclosed for district wise deployment of field staff to ensure release of payment to contractual/outsourced worker from concerned department.

All the District Heads are directed to submit a daily report to Addl.Labour Commissioner (Admn) without fail so that a compliance report is sent to Chief Secretary, Delhi every 2nd day.
