- 4) The Registrar Co-operative Societies reserves the right to reject any or all tenders without assigning any reasons thereof.
- 5) The successful bidder shall be required to furnish a Performance Security within one week of receipt of "Letter of Offer". The Performance Security will be 10% of the tendered amount quoted by the successful bidder in the form of Fixed Deposit Receipt from a commercial bank in favour of D.D.O O/o Registrar Cooperative Societies, Old Court Building, Parliament Street, Connaught Place, Delhi-110001. The Performance Security shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations.
