All MLOs / MLO (HQ)/CMVI / ARU (Burari) are requested to accept the Base model **SAARTHI** manufactured by M/s M/s Champion Poly Plast, 487/68, Peera Garhi Industrial Area, New Delhi-110 087 in NCT of Delhi subject to fulfillment of provisions of Motor Vehicle Act, 1988 and rules made there under and the department's instructions/order issued from time to time in this regard.
