CIRCULAR

The Competent Authority is pleased to endorse the Certificate No. CALA 0169 L01 dated 17th November 2016 with reference to Base Type Approval Certificate no. CALA 0169 dated 12th October, 2016 issued by designated testing agency i.e. ICAT, Manesar, Gurgaon in respect of CNG Kit identification "Wagon R BS IV OBD II" and on the basis of layout plans submitted by the manufacturer/ kit supplier / retrofitter, the ICAT has certified that retro-fitment of above CNG kit manufactured by M/s Rohan BRC Gas Equipment Pvt. Ltd., Plot. No 291-304, Panchratna Industrial Estate, Beside IOC Petrol Pump, Sarkhej- Bavla Road Ahmedabad, Changodar, Taluka – Sanand, Dist. Ahmedabad-382213, India, on the MPFI "in-use", base model "Maruti Wagon R Vxi (April 2013 make)" for retro fitment on "in-use" gasoline vehicles manufactured/registered from 01st April, 2013 till the validity of Bharat Stage IV norms falling within the stipulated engine capacity 748.5 to 1247.5 cm3. The CNG Kit is duly approved by the designated agencies i.e. ICAT Manesar Gurgaon for compliance to the Central Motor Vehicles Rules.


The same CNG Kit can therefore be fitted to MPFI "in-use" base models/variants given at "Annexure-II" of CALA 0169 L01 dt. 17th November 2016 (Enclosed), as they are within prescribed ± 25% cm3 range.

Validity – This certificate is valid upto 11.10.2019 i.e. 3 years from the date of issue of base type approval certificate no. CALA 0169 dated 12th October 2016 or until further amendment in CMVR Rules, whichever is earlier.

Kit Manufacture/Supplier/Distributor is directed to ensure the strict compliance of CMVR Rules 1989. The retro-fitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components, parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the ICAT at the time of submission of vehicle for inspection/endorsement of CNG in registration certificate.

The Kit Manufacture/Installer must comply with Annexure-II to the TAC No CALA 0169 dated 12th October 2016, and also invariably enclose its certified copy along with CNG installation certificate (Annexure VI) and checklist (Annexure-VII) of AIS:024 and specific layout plan of model approved by ICAT.

All MLOs/Registering Authorities shall, at the time of endorsement of CNG fuel in registration certificate, verify the CCoE approval for the CNG cylinder and cylinder Valve, in respect of make/identification number (as referred in Technical Specification of CNG system endorsed by ICAT) and documental reference for quantity/Sr.No. Cleared by DoE, time to time. Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & condition and validity given in the type approval certificate subject to fulfillment of provisions of Motor Vehicle Act, 1988 and Rules made there under and department instruction/order issued from time to time in this regard.



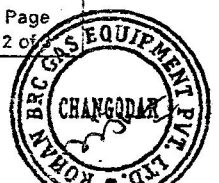
