

OFFICE MEMORANDUM

In suppression of earlier Office Memorandum No. F. 25(III)/DGEHS/470/DHS/2015-16/147598-835 dated 03/02/2016 whereby it was advised that number of the Injection of Anti-VegF (Lucentis/Acentrix etc) shall be upto 3 only and seek permission for more then 3 if required. In this regard, it has been decided in consultation with experts that number of injection can not be restricted and it may be repeated in patients who get benefit with this medication. Therefore, the restriction as communication vide aforesaid OM dated 03/02/2016 for number of Injection is withdrawn. Since the payment is being made as per rates of AIIMS i.e. Rs. 18, 379/-and procedure charges i.e. Rs. 3,000/- for Non-NABH centre and 3, 500/- for NABH hospital/centre. Therefore there is no need to seek permission of this directorate for administration of Injection Lucentis.
