2. To provide names of personalities to be included in the list of advertisements on the birth-death anniversaries.

Sir,

It is with reference to the judgment of the Supreme Court of India dated May 13, 2015 with regard to the regulation of government advertisements. A copy of said judgement is available on the official website [http://delhi.gov.in/wps/wcm/connect/DOIT\\_Publicity/Information.pdf?\\_id=20150513](http://delhi.gov.in/wps/wcm/connect/DOIT_Publicity/Information.pdf?_id=20150513).

The judgement states that-

The Government shall-

- 1. Decide and announce beforehand a list of personalities on whose birth or death anniversaries advertisements could be released every year and specify which Ministry/Department could release the same.
- 2. Avoid the issue of multiple advertisements by different departments and PSUs of the same Government or Commemorative Advertisements and shall issue a single advertisement only."

In view of the above it is requested to prepare a list of such personalities on whose birth or death anniversaries your department intends to release government advertisement and send it to DIP within a week.

Once the names from all Departments of GNCT of Delhi are received, a draft consolidated list shall be put up for the approval of the Competent Authority.
