

I am directed to say that Deptt. of Pension & Pensioners' Welfare has planned to make use of Bhavishya mandatory by December, 2016 and therefore, viewed/desired to link the e-awas package of Directorate of Estates with Bhavishya – an online tracking system for sanction of payment of pension and other retirement dues, developed by Department of Pension & Pensioners' Welfare, so that the retiring allottees/employees would get "No Dues Certificate" in time.

As per Rule 57 of CCS (P) Rules, 1972 (as amended) " The Head of office shall write to the Directorate of Estates at least one year before the anticipated date of retirement of the Government servant who was or is in occupation of Government accommodation (hereinafter referred to as the allottee) for issuing a 'No Demand Certificate' in respect of the period preceding eight months of the retirement of the allottee".

In this regard it is stated that all the Ministries/Departments of Govt. of India, are hereby requested to transmit the Licence fee recoveries of their allottees of GPRA through online, for issuance of NDC expeditiously. Further, the offices of Govt. of India are also requested to comply with the guidelines issued by DoPPW and approach the retiring Allottees in their office to fill the NDC online form One year (12 months) before the date of retirement, to facilitate the issuance of NDC/NOC expeditiously from Directorate of Estates. As this Directorate is making necessary provisions in e-Awas Software, to link e-Awas Application in respect of the NDC request in terms of Rule 57 of CCS (Pension) Rules, 1972 (amended) with the Bhavishya software.
