

This issues with the prior approval of Competent Authority.





**CIRCULAR**

Delhi Right to Education Rules, 2011 has been amended vide notification dated 25.03.2013, with a view to safeguard the interest of children/student studying in the pre-existing unrecognized schools. Further the procedure of grant of provisional recognition to such schools has been simplified and land area norms have also been relaxed so that such schools can be granted provisional recognition expeditiously.

Pursuant to aforesaid notification, this Directorate has granted provisional recognition to schools which are running classes up to Primary level/Elementary level, in form IIA, for the period of one year.

Such provisional recognition was granted prior to inspection of the schools and only on the basis of fulfillment of the relaxed land norms and the condition of the school being in existence as on 01-04-2010.

All the files related to schools, which have been granted provisional recognition up to primary level by the Director of Education under the amended Delhi Right to Education Rules 2011, have been forwarded to the respective Municipal Corporation of Delhi, being the competent authority, for taking necessary action such as physical inspection and grant of regular recognition to such schools. The respective Municipal Corporation of Delhi are processing the file's for further necessary action in this regard.

The current academic session 2013-14 has ended and the students passing out of class V of such primary schools, which have been granted provisional recognition, shall require School Leaving Certificate for getting admission in other Government /Govt. Aided /Private Unaided schools for completion of their Elementary Education.

The matter of countersigning the School Leaving Certificate issued by such schools was taken up with respective Municipal Corporation of Delhi for issuance

necessary direction in this regard but the three Municipal Corporations of Delhi are yet to issue direction in this regard.

Therefore, in view of above and in the interest of continued education of children studying in such schools, all the zonal Education Officer/Deputy Education Officers of the Directorate of Education are hereby directed to countersign, within their area jurisdiction, the School Leaving Certificate issued by those unaided public schools which have been granted provisional recognition up to class V (Primary Level) under the Right to Education Act 2009 by the Directorate of Education.
