CIRCULAR

Sub: Reimbursement of per child expenditure of pending cases to Pvt. Unaided Schools in r/o EWS/DG category Students admitted under the provisions of RTE Act for the academic sessions 2014-15, 2015-16 & 2016-17.

1. All Heads of unaided recognized schools of Delhi (under DOE/MCD's/NDMC/DCB) are again directed to submit the details of students admitted under EWS & DG category during 2014-15, 2015-16 & 2016-17 session (*if not entered earlier*)/ (**the defaulters list is attached**) in the online module using school login ID & password at link **School Plant=> EWS** in the web portal of this Directorate (www.edudel.nic.in) by using Internet Explorer (the defaulters list is attached). Information against all items must be filled with due care and no item shall be left blank. **Printout of the online report** duly certified by HOS shall be submitted at the earliest to the DDE (zone) concerned.
2. The schools that have entered data but claims not processed /approved due to errors in the entered data are advised to get them corrected on priority basis.
3. The DDEs (Distt./Zones) are advised to check & approve all pending cases of reimbursement of per child expenditure to pvt. unaided schools in r/o EWS/DG category students admitted under the provisions of RTE Act for the academic sessions 2014-15, 2015-16 & 2016-17. Based on the approvals online by DDE(zone), budget will be allocated by Planning Branch to district concerned.
4. In the event of variation between the entered data and the status found through physical inspection, data submitted shall be rejected and Pvt. Unaided school will be required to correct and re-submit the same in the online module.
5. Private unaided schools of MCD's (North DMC, South DMC & East DMC) /NDMC/DCB shall submit data online. DDEs(Edu.)/ ADEs(Edu.) of concerned local bodies are advised to forward **duly certified printouts of the online report** submitted by private un-aided schools in hard copy to Planning Branch of this Directorate of Education for processing.
