CIRCULAR

REG: W.P.(C) 10148/2017 AND CM NO. 41463/2017-SALEEM & ORS Vs DDA  
& ORS. IN THE HIGH COURT OF DELHI

The Hon'ble High Court of Delhi in the aforesaid matter has directed the GNCT of Delhi to look into the aspect of provision of school uniforms, books and stationery to those children of Kathputli Colony who have lost the same on account of demolition and the transit.

The Hon'ble Chief Minister, Delhi has also desired that the order dated 16.11.2017 of the Hon'ble High Court of Delhi be complied with immediately.

In order to comply with the above said directions, the Directorate of Education needs the whereabouts/rehabilitation status of the displaced families of Kathputli Colony so that the children of these families may be provided with the school uniforms, books and stationery items.

In view of above, all the HOSs of DOE Schools, DOE aided schools and un-aided schools recognised by DOE are therefore, directed to identify the students with address of Kathputli Colone and furnish the said information on priority basis to the office of the undersigned through E Mail: rdewest@gmail.com by 30.11.2017 in the following format.

The HOSs must assess which student is in need of uniform, books and stationery which may have been lost on account of demolition & transit of their families from Kathputli colony (near Patel Nagar, West Delhi).

The HOSs of DOE Schools may utilize either Pupils Welfare Fund or Vidhalaya Kalyan Samiti Fund to purchase books, writing material & Uniform from the market & provide the same to the students immediately.

DOE aided and un-aided recognized schools may purchase the same from the funds available with the schools.

The claim for expenditure of bills must be submitted to the concerned Distt. Dy. Director of Education for reimbursement.

Last date for submission of bills shall be 15th December, 2017.

HOSs are also to ensure that no child drops out of the schools or misses classes for want of uniform, text-books and writing material and students are encouraged to continue with their schooling.
