
CIRCULAR

It has been observed that while preparing preliminary estimates for Capital Works the Executing Agencies are adopting 'Schedule of Rates' issued by DG, CPWD for commonly executed work. However, they are finding it difficult to arrive at a uniform rate / standard rate for 'Non Scheduled items' of work and have to do their own research/assessment to arrive at a rate through past tenders or market inquiry.

02. Therefore, in order to bring standardisation/ uniformity in the rates of non scheduled items /Market Rate items, Work Executing Agencies, in addition to making their own independent assessment/ Market Survey, are also advised to use/refer the rates from GeM Portal for the items for which rates are not readily available.

03. Source from which the rates are adopted for non-scheduled items of work shall be mentioned in the remarks column of the 'Abstract of Cost'.
