An undertaking may be attached with the monthly report that no other court cases are pending except mentioned in this monthly report and the sender branch in-charge will be solely responsible for any lapse.

You are, therefore, once again requested to visit the "e-Litigation" portal and identify the court cases pertaining to your zone/branch out of 116 court cases reflecting on "e-Litigation" portal, while updating the software immediately and send the updated monthly report by December, 20th 2016 to the L&P Branch .(proforma enclosed)
