Sub: Fixation of pay in respect of re-employed teachers.

Madam,

As per the OM No. 3/3/2016-Estt. (Pay II) dated 01-05-2017 of Ministry of Personnel, Public Grievances & Pension, Department of Personnel & Training, Govt. of India Re-employed pensioners shall be allowed to draw pay only in the Level in the revised pay structure applicable to the post in which they are re-employed and no protection of the scales of pay/pay structure of the post held by them prior to retirement shall be given.

It has been observed from the pay fixation orders dated 16-03-2017 issued by the Dy. Director of Education, District East (copy enclosed) that the pay fixation of one Sh. Ishender Kumar Kulshrestha, Retired and Re-employed PGT (Physics) the pay fixation has been done in Pay Matrix Level 9 which should have been fixed in Pay Level 8 as per the provisions of above said OM dated 01-05-2017 of the Govt. of India.

The fixation of pay in this case in Pay Level 9 would entitled the re-employed person to draw the Transport Allowance on higher side i.e. @ Rs. 7200/- per month whereas he would eligible for drawl of Transport Allowance @ Rs. 3600/- per month.

You are requested to look into the matter personally and arrange to issue necessary instructions to the concerned offices of your department to fix the pay of re-employed pensioners under the provision of OM dated 01-05-2017 of Govt. of India to avoid the excess drawl of payments.

Ishender Kumar Kulshrestha, Retired & Re-employed PGT (Physics) is hereby fixed as under :

1. Last Basic Pay drawn as per 7th C.P.C.

- Rs.77,900/-

2. 7th C.P.C. Pay Matric Level

9

- Rs.38,950/-

3. Less Basic pension authorized on retirement

- Rs.38,950/-

4. Pay to be refixed as on 01/08/2016

Further, the HRA and DA will be drawn on the last pay drawn at the time of retirement. The re-employed teacher will not be paid Dearness Relief on pension during the period of Re-employment. If Dearness Relief is paid on pension, then the same may be recovered by the HOS concerned under intimation to the bank concerned accordingly. The Transport Allowance be also revised according to the post on which the official appointed initially.
