


Sub: Payment of cash subsidy in lieu of Text Books and Uniform through ECS at school level.

In continuation of this office circular of even no. 2438-2441 dated 19.09.2017 and 2445-48 dated 20.09.2017, All the HoSs of Delhi Govt. Schools are informed that the funds are being allocated for remaining 3426 students (General and SCSP) in Text Books & Writing Material and 3579 students (General and SCSP) in Uniform Subsidy as on date. HoSs of respective schools are directed to make payment to these remaining students through ECS upto 18.11.2017. List of the students is also being provided to the school along with the circular.

In this regard, HoSs are advised to submit the bill before the concern PAO in respect of those students whose name and eligible amount are given in attached list along with special C. D. "through Special DDO ECS Instruction" as schools are doing the same earlier.

All the RDs / DDEs are requested to monitor the matter and ensure that the payment must be disbursed by 18.11.2017.


