

It has come to the notice of this Directorate that some of the departments of GNCTD are not providing the list of officers/officials month wise to Anti Corruption Branch for deployment of staff as Punch Witness, which creates a very difficult situation to ACB, during raid etc.

Some of Departments have been requesting to exempt their department, due to shortage of staff. Every Department has been facing this problem and demand of one employee in a day for punch witness duty may not affect the work of the concern department. Hence, the request of exemption for deployment of staff can not be considered.

It is pertinent to mention that Punch Witness duty is very important and sensitive in nature and abrupt non deployment seriously impedes the whole process of Anti Corruption process being taken by the ACB, GNCTD.

I am directed to request you to ^{update} provide the list/details of all the suitable officers/officials monthwise, along with their residential address as well as telephone Numbers direct to ACB urgently, through return FAX for deployment as Punch Witness in ACB, under intimation to this Directorate.

This may also ensure that no officer/official is deputed for punch witness duty in ACB against whom any criminal case is pending or he/she is of doubtful integrity. He/She should not be below the rank of Gr.-IV(DASS)/LDC. In case, any officers/officials (deputed for punch witness duty) is on leave/transfer/promotion/retired, the same may be informed well in advance along with the name of proposed or suitable substitute to ACB.
