

Sir,

The pension cases of all the pre-2016 pensioners are required to be revised in accordance to the OM No.38/37/2016-P&PW(A) dated 12.05.2017 issued by the Deptt of P&PW, M/o Personnel, PG&Pension (copy enclosed) by notionally fixing their pay in the pay matrix recommended by the 7<sup>th</sup> CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/died. The notional pay fixation would be done under each intervening Pay Commission based on the formula of revision of pay.

It is, therefore requested to take action for fixation of notional pay of all the pre-2016 retirees of your department as per the above said OM and submit the revision of pension / family pension case to this office urgently.

For your perusal a list of retirees whose pension/family pension is required to be revised at your end is enclosed herewith. Also the performa in which the revision of pension case is required to be further send to the CPAO is also enclosed for your perusal and providing of necessary information accordingly to this office on urgent basis.
