Sub: Implementation of Governments decision on the recommendations of the Seventh Central Pay Commission- Revision of pension of pre-2016 pensioners/family pensioners etc.

Sir,

In continuation to this office letter of even no dated 04.07.2017, the additional list of pensioners wherein the revision is required to be made as per the 7th CPC are enclosed herewith for necessary action at your end.

These pension cases of pre-2016 pensioners are required to be revised in accordance to the OM No.38/37/2016-P&PW(A) dated 12.05.2017 issued by the Deptt of P&PW, M/o Personnel, PG&Pension (copy enclosed) by notionally fixing their pay in the pay matrix recommended by the 7th CPC in the level corresponding to the pay in the pay scale/pay ban and grade pay at which they retired/died. The notional pay fixation would be done under each intervening Pay Commission based on the formula of revision of pay.

The duly attested calculation sheet of notional pay fixation and of revised pension may accordingly be submitted to this office for further revision of pension of the pensioners as per the 7th CPC.
