





This issues with the approval of Chief Secretary/CVO, GNCTD.

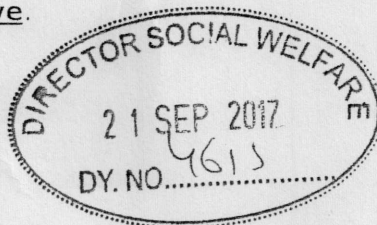
