Extn. Certificate No. CAEA 0088 E03 dated. 20/07/2017

The approval of Competent Authority is hereby conveyed to endorse the change in specifications as attached to Annexure 1 of **Certificate No. CAEA 0088 E03 dated 20.07.2017** of base certificate No. CAEA 0088 dated 05.10.2009 issued by the ICAT and extended vide certificates No. ICAT/CMVR/365(R1)/H-0704 dated 22.11.2012 and ICAT/CMVR/517(R2)/K-0948 dated 04.11.2015 from 05.10.2009 to 04.10.2018 to **M/s Mijo Auto Gas Pvt. Ltd. (ISO 9001 : 2008 COMPANY), S-110, Badli Industrial Area, Phase – I, Delhi – 110 042. The Annexure 1** of CAEA 0088 E03 dated 20.07.2017 is annexed herewith.

**Validity** – This certificate is valid upto 04.10.2018 as certified by M/s. ICAT vide certificates Nos. ICAT/CMVR/365(R1)/H-0704 dated 22.11.2012 and ICAT/CMVR/517(R2)/K-0948 dated 04.11.2015.

The kit Manufacture/Supplier/Distributor is directed to ensure the strict compliance of CMV Rules 1989. The retro-fitment should be carried out by the authorized workshops only. Further, approval is accorded subject to ensuring fitment of same components; parts/assemblies etc. details of which are given in the detailed specification duly endorsed by the ICAT.

**The Kit Manufacture/ Installer must comply with Annexure-I to the TAC No. CAEA 0088 E03 dated 20.07.2017 and also invariably enclose certified copy of specifications along with CNG installation certificate (Annexure VI) of AIS: 024 and specific layout plan of model approved by ICAT.**

All MLOs/Registering Authorities shall, at the time of endorsement of CNG fuel in registration certificate, verify the CCoE approval for the CNG cylinder and cylinder Valve, in respect of make / identification number (as referred in Technical Specification of CNG system endorsed by ICAT) and documental reference for quantity / Sr. No. cleared by DoE, time to time. Further, it should also be ensured that the fitment of kit must be in accordance with the layout plan for fitment, terms & condition and validity given in the type approval certificate subject to fulfillment of provisions of Motor Vehicle Act, 1988 and Rules made there under and department instruction / order issued from time to time in this regard.

The endorsement of in-use vehicle will be done by Registering Authorities/MLOs only through the online software developed by NIC.
