### OFFICE MEMORANDUM

New eligibility conditions have been added for admissions in Full-time Diploma Level Courses, through lateral entry (CET, Test-5) Academic Year 2018-19. This office has received letters, from some of the institutes, seeking clarification regarding allocation of Roll No. code to the students admitted through lateral entry for current Academic Year.

In this connection, it is to inform that, it has been decided to keep the prevailing coding system unchanged in r/o the students admitted through lateral entry and is as follows.

Now, you are hereby advised to inform all concerned students regarding coding pattern of Roll No., Institute code, branch code, etc. to avoid any mistake while writing their Roll Nos. during Examination period

The 10 digit Roll No. have been allotted to all student who had taken admission in 1<sup>st</sup> semester during academic year 2013, except lateral entry students. Lateral entry students admitted in 3<sup>rd</sup> semester in 2013, are being allocated 6 digit Roll No. on previous pattern. However, the lateral entry students who will be admitted in 2014 in 3<sup>rd</sup> semester, will be allocated 10 digit Roll No. (Also shown at the end of below mentioned examples).

The Examination cell of the BTE has allowed 10 digit Unique Roll Nos. to all the students for odd semester theory examination, scheduled from Dec.-2013. However, the allotment & verification regarding correctness of Roll Nos. will be done at Institute's level, during all future exams..

It is further informed that a workshop in connection with the introduction of 10 digit Roll No. will be organized in the office of BTE in Room No.19 on 27/11/2013 from 2.30 PM to 3.30 PM. All the polytechnics may send their one/two representative to attend the said work-shop during which they may clear doubts on the issue, if any.
