CIRCULAR

SUBJECT : FILLING UP THE POST OF LAW OFFICER IN DELHI JAL BOARD ON DEPUTATION BASIS.

Applications are invited from eligible officials of Delhi Jal Board for filling up one post of Law Officer in the pay band 3 of Rs.15600-39100 with the Grade Pay of Rs. 7600/-(Pre-revised) in Delhi Jal Board on (Composite method) deputation (Including Short–term contact)Plus promotion. The eligibility criteria to apply for the post as under:-

Eligibility criteria for deputation	Officer under the Central/State Goverment/UTS/Universities/Recognized Research Institutions/PSUS/Semi Government OR Autonomous OR Statutory Organizations:- (A) (I) Holding analogous post on regular basis in the parent cadre/ department; or II) with 5 years service in the grade rendered after
	appointment thereto on a regular basis in PB-3, Rs. 15,600/39100/- with Grade Pay of Rs. 6500/- (Pre-revised) or equivalent in the parent cadre/ department; OR III) A member of the state judicial service with ten years of regular service. AND
Educational Qualification and experience required	(i) Bachelor's degree from a recognized university/institute AND (II) Three Years Bachelor's degree in Law from a recognized university institute AND (III) Seven year experience as legal practitioner or Seven year experience in legal work OR (I) Five year integrated degree in law from a recognized university / institute : AND (I) Eight year experience as legal practitioner or Eight years experience in Legal Work

Note 1:-The departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2.:- (Period of deputation (ISTC) including period of deputation (ISTC) in another Excadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not to exceed four

years. The maximum age-limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 3:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1ST January of 2006 (the date from which the revised pay structure based on the 6TH CPC recommendations has been extended) shall be deemed to service rendered in the corresponding grade pay /pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any up-gradation.

The departmental Assistant Law Officer in pay band 2. Rs.9300-34800/- with grade pay of Rs.4600/- with twelve years of regular service in the grade will also be considered alongwith deputationists and in case he/she is selected for appointment the post shall be deemed to have been filled by promotion.

The applications of suitable and willing officers must reach the office of the undersigned through proper channel along-with their complete bio-data in the enclosed format, integrity certificate and ACR Dossier for the last five years within 60 days of issue of this circular.
