**Subject : "Simple Accounts Test" scheduled to be held on 23.07.2018 through CPWD at "New Delhi" Examination Centre for the Junior Engineers (Civil)/(E&M) of Delhi Jal Board.**

According to the existing policy, Junior Engineers (Civil)/(E&M) are required to qualify the Accounts Test, within a period of two year/or until they are provided at least four chances from the date of their appointments so as to qualify themselves for the grant of further annual increments.

Hence, to provide such opportunity at regular intervals, "Simple Account Test is being conducted twice in a year through CPWD. Now for the 3<sup>rd</sup> time it's **scheduled to be conducted on the 23<sup>rd</sup> July, 2018 (10.00 AM to 1.00 PM) at the New Delhi Examination Centre of CPWD.**

Accordingly, copy of Notification No.01/01/2018-Exam/40 dated 16<sup>th</sup> April, 2018 issued by the O/o Addl. Director General of Training, National CPWD Academy (Exam Cell) **along with the Proforma for application as Annex. – III (Part –I & II) is enclosed herewith with the direction that all the Junior Engineers (Civil)/(E&M) working on regular basis and who have not yet passed the said test may submit their application (in Triplicate) in the enclosed format (Part –I & II) as per the directions given hereunder :**

1. The application (Part –I & II) **(in Triplicate with Good Print)** be submitted to this office on or before 10<sup>th</sup> May 2018 along with Examination fee in the shape of Demand Draft of Rs.2000/- (Rs. Two Thousand Only) drawn in favour of **"Executive Engineer(E), ED-IX, C.P.W.D., New Delhi"**. It may be noted that after said date, no application/request will be accepted/entertained.
2. Name, Designation, (Office Name) C/o DJB & Mobile No. must be mentioned on the back side of Demand Draft.
3. The "PIMS ID" in the application is not applicable for DJB Employees.
4. Name of Centre is to be mentioned as **"New Delhi"**.
5. Name of Paper is to be mentioned as **"Simple Account"**.
6. The Examination Fee is not refundable.
7. In case the full information is not furnished, the application for the paper will be rejected summarily without any prior intimation.
8. The syllabus for the said exam includes CPWD Manual, Contractor Bills, Contract Documents, Delegation of financial Power of CPWD.
9. Schedule for coaching classes to be arranged by DJB will be issued separately for the candidates appearing in the Accounts Test.

The Departmental Examination in Accounts etc. for Junior Engineers/SO(H)/Assistant Engineers/AD(H)/Assistant Executive Engineers and Executive Engineers/DD(H) will be held from 23.07.2018 to 27.07.2018 (**Annexure-I**).

2. All the Superintending Engineers are requested to advise all the officers (attached to their circles) who have not yet passed the prescribed Examination that they should appear in the forthcoming examination positively.

3. Assistant Executive Engineers (Civil/Elect.) can apply for the Departmental Accounts Examination prescribed for EEs(C/E) only when they have passed all the papers of Departmental Accounts Examination prescribed for AEEs (C/E).

4. Regularly promoted Assistant Engineers having minimum 7 years' service in the grade as on 27.07.2018 shall also be allowed to appear in the Departmental Examination meant for Executive Engineers provided they have already passed the Departmental Accounts Examination of AEs (C/E)/AD(Hort.).

5. Junior Engineer's (Civil/Elect.) having minimum 5 years regular service in the grade as on 27.07.2018 shall also be allowed to appear in the Departmental Examination in Accounts meant for Assistant Engineers provided they have already passed the Departmental Accounts Examination of JEs (C/E)/SO(Hort.).

6. A list showing Regional Controller of Examination and Officer-in-charge of the Examination Centers and the areas covered by each center is also attached (**Annexure-II**). The candidate can be paid T.A. as admissible under the rules. **Examinees should send their applications (in duplicate) latest by 25-05-2018 to the Officer-in-charge of Examination Center (through their Controlling Officer)**

They should clearly state the paper in which they want to appear and mention separately the papers in which they have already been granted exemption indicating the Roll No., Year of passing the examination and the number and date of this office reference for verification. An attested copy of the office reference may also be sent. The proforma for application is enclosed (Annexure-III).

7. The candidates will have the option to answer the Question Paper(s) in Hindi. The answering of a Question Paper partly in Hindi and partly in English will not be permitted. The option once exercised by the candidates in this regard will be final and they will not be permitted to withdraw it. It may however, be made clear that it will not be possible to make available Hindi translation of all the codes and Manuals and other literature for reference, for answering relevant questions in Hindi. The officer-in-charge of examination centre are requested to forward to this office the name of such candidates who opt to answer in Hindi.

8. The candidates other than those borne on the Central PWD cadre have to pay the examination fee of Rs. 2000/- (Rupees Two Thousand only) per paper in which they intend to appear. The officer-in-charge of the Examination center may accept their application along with the examination fee only. The amount, when received may be remitted to the Government Treasury under the Head of Accounts 0059-Public-Works other Receipt (Examination fee).

9. It may please be noted that no request for change of center will be entertained.

10. It may also be noted that no request for re-checking of answer sheet/supplying of copy of answer sheets shall be entertained.

11. Syllabus of the examination and passing criteria shall be as per CPWD manual on Regular establishment and office procedure 2013 with up to date amendment. ADG Training has also full powers to take decision in all the matters related to any malpractice and submitting false or incorrect statement by any candidate and also any ineligibility being detected in respect of the candidate before or after the examination. His decision on any dispute will be final and binding.

12. The copy of the notification along with the application form can be downloaded from the CPWD Web site [www.cpwd.gov.in](http://www.cpwd.gov.in) or it can be obtained from the Officer-in-charge of the examination center. Filled applications are to be sent to respective examination centres which is opted by the applicant.

13. The Application will be summarily rejected if directly forwarded to the O/o ADG (Trg.) National CPWD Academy, Kamla Nehru Nagar, Ghaziabad or Assistant Administrative Officer (Exam Cell), O/o ADG (Trg.) National CPWD Academy, Kamla Nehru Nagar, Ghaziabad, without any prior intimation.




