CIRCULAR

Subject: Extension of timelines upto 30-06-2018 from levy of Rain Water Harvesting Penalty in case where provision of Rain Water Harvesting System has not been made and Levy of Additional Sewer Charges where Borewells are working - in Dwarka Area.

Reference is invited to Circular NO.DJB/DOR/DD(R)HQ-I/2018/1322 to 1461 dated 23-02-2018 and NO.DJB/DOR/DD(R)HQ-I/2018/1181 to 1321 dated 23-02-2018 regarding extension of timeline for exemption from (i) Levy of Rain Water Harvesting penalty and (ii) Additional Sewer Charges f or use of Ground Water through Bore Wells; in respect of Dwarka Area upto 30-06-2018.

- 2. As per decision of the Board vide Resolution No.610 dated 9-07-2018, above timelines have been extended upto 31-08-2018.
- 3. Concerned S.E./J.D.(R) & E.E.(W/S/R)/Z.R.O. are advised to give wide publicity to this extended period and consumers may be advised to take necessary action within prescribed period for installation of Rain Water Harvesting and removal of borewells for extraction of ground water to avoid levy of Rain Water Harvesting penalty and Additional Sewer Charges.
